



OUR PLANS

Over the next year, we will focus our efforts on developing a watershed plan for the Rio de Flag. We will integrate community input and engage a diversity of stakeholders in developing a robust plan that addresses important socioecological needs of our watershed. At the same time, we will expand the Rio de Flag Adopt program to involve more students in stewardship and citizen science projects along the Rio.



Watershed Planning

We aim to collaborate with multiple stakeholders including the City of Flagstaff, Coconino County, and others in developing a Rio de Flag Watershed Plan. We will seek funding through public, private, and governmental entities to support the planning process.


